Mayor Traugott presented Resolution 2023-17 Honoring the Life of Nickie Shyrock. He noted that Nickie was a lifelong resident of Versailles, served in the United States Army, had long career with the Versailles Police Department, served on the Versailles City Council, and worked for fourteen years as a Licensed Funeral Director. He praised his commitment to serving his community and his country, as well as being a husband and father.

MOTION BY BINGHAM, SECONDED BY BRADLEY TO APPROVE AND ADOPT RESOLUTION 2023-17 HONORING THE LIFE OF NICKIE SHYROCK AND ADJOURNING TONIGHT'S COUNCIL MEETING IN HIS MEMORY.

#### **Public Comment**

An anonymous citizen was present to express her concerns over short term rentals, particularly in single family areas such as Merewood. She noted that there are known short term rentals that are renting out each room in the house, which results in several cars coming and going from that home. Mayor Traugott stated that short term rentals are not currently allowed in R-1 zones, like Merewood. The citizen asked who is responsible for the enforcement of zoning ordinances? Mayor Traugott stated that the City's Code Enforcement Officer is empowered to enforce zoning ordinances but they are hard to enforce – for example how do you determine if someone is renting their home out and/or if the people living there are family? He also noted that nuisances as a result of those short term rentals can be more easily enforced.

MOTION BY BRADLEY, SECONDED BY BINGHAM TO APPROVE AND ADOPT THE MINUTES OF THE SEPTEMBER 5, 2023 REGULAR COUNCIL MEETING.

Rich Pictor, Director of Parks and Recreation, and Jon Gay, Chair of the Parks and Recreation Board were present to discuss the next steps of the Parks and Recreation capital projects. Mr. Pictor stated that they had been before the Council previously to ask for the City's support of approximately \$6 million in improvement projects including Big Spring Park, new lighting for baseball and softball fields, and new pickleball courts. Mr. Pictor noted that they are hoping for the communities input on other projects that have not yet been vetted, as well as possibly applying for grants for additional funding. Mayor Traugott asked about their vision for oversight and what the next step is? Mr. Gay responded that the Parks and Recreation Board would like the City and County to make a commitment to fund the total project costs and then they could create a Board or a group for oversight. Mayor Traugott stated that the City does not anticipate bonding the City's portion of the project costs. The Council asked Mr. Pictor to attend the Work Session on October 10<sup>th</sup> to further discuss funding the projects.

TITLE: AN ORDINANCE AMENDING SECTION 35.22 OF THE VERSAILLES CODE OF ORDINANCES TO PROHIBIT OFFICERS AND EMPLOYEES FROM RECEIVING REMUNERATION IN EXCHANGE FOR PUBLIC ENDORSEMENTS OF PRODUCTS OR SERVICES.

Whereas, the City desires to amend Section 35.22 of the City's Code of Ordinances to prohibit officers and employees from receiving remuneration in exchange for public endorsement of products or services;

NOW, THEREFORE, BE IT ORDAINED IN THE CITY OF VERSAILLES, KENTUCKY as follows:

Section 1. Section 35.22 of the Versailles Code of Ordinances is hereby amended as follows: § 35.22 Endorsements.

No officer or employee in his official capacity may publicly endorse products or services <u>in exchange for any remuneration</u>. However, this does not prohibit an officer or employee from answering inquiries by other governmental officials, consumer organizations, or product information services regarding products or services.

Section 2. This ordinance shall become effective after passage and publication as required by law. Introduced and given first reading at a meeting of the City Council of the City of Versailles, Kentucky, held on the 5th day of September, 2023, and fully adopted after the second reading at a meeting of said council held on the 26th day of September, 2023.

Whereas, the City desires to amend Section 35.50 of the City's Code of Ordinances to prohibit members of the Board of Ethics from also being candidates for political office or officers of a political party and to reschedule the annual meeting of the Board of Ethics to February 1;

NOW, THEREFORE, BE IT ORDAINED IN THE CITY OF VERSAILLES, KENTUCKY as follows:

Section 1. Section 35.50 of the Versailles Code of Ordinances is hereby amended as follows: § 35.50. Board of Ethics created.

•••

(B) The Board of Ethics shall consist of five (5) members who, by agreement with municipal authorities, shall be appointed by the executive authority of the county and the cities of Versailles and Midway, subject to the approval of the respective legislative body. The initial members of the Board of Ethics shall be appointed on or before March 3, 1995. No member of the Board of Ethics shall hold any elected or appointed office, whether paid or unpaid, be a candidate for any political office or an officer of a political party, or any position of employment with the cities or county or any cities or county agency. The members shall serve for a term of three (3) years; except that with respect to the members initially appointed, one (1) member shall be appointed for a term of one (1) year, two (2) members shall be appointed for a term of two (2) years and two (2) members shall be appointed for a term of three (3) years. Thereafter, all appointments shall be for a term of three (3) years. The county and cities shall agree on the initial terms of the respective appointment of each. Woodford County and the City of Versailles shall have two (2) representatives on the Board of Ethics, and the City of Midway shall have one (1) representative, all being approved by the respective legislative bodies. Each member of the Board of Ethics appointed by the cities or county shall have been a resident of the county for at least one (1) year prior to the date of the appointment and shall reside in the county throughout the term in office. The members of the Board of Ethics shall be chosen by virtue of their known and consistent reputation for integrity and their knowledge of local government affairs. The members may be reappointed for any number of consecutive terms.

Whereas, the City desires to amend Section 35.59 of the City's Code of Ordinances to remove the confidentiality provisions relating to advisory opinions.

NOW, THEREFORE, BE IT ORDAINED IN THE CITY OF VERSAILLES, KENTUCKY as follows:

Section 1. Section 35.59 of the Versailles Code of Ordinances is hereby amended as follows: § 35.59 Advisory Opinions.

- (A) The Board of Ethics may render advisory opinions concerning matters under its jurisdiction, based upon real or hypothetical facts and circumstances, upon its own initiative, or when requested by any officer or employee of the city or a city agency who is covered by this chapter.
- (B) An advisory opinion shall be requested in writing and shall state relevant facts and ask specific questions. The request for an advisory opinion shall remain confidential unless confidentiality is waived, in writing, by the requester.
- (C) The Board may adopt regulations, consistent with the Kentucky Open Records Law, to establish criteria under which it will issue confidential advisory opinions. All other advisory opinions shall be public documents, except that before an advisory opinion is made public, it shall be modified so that the identity of any person associated with the opinion shall not be revealed.
  - (D) The confidentiality of an advisory opinion may be waived either:
    - (1) In writing by the person who requested the opinion.
- (2) By majority vote of the members of the Board, if a person makes or purports to make public the substance or any portion of an advisory opinion requested by or on behalf of the person. The Board may vote to make public the advisory opinion request and related materials.

- (E) (C) A written advisory opinion issued by the Board shall be binding on the Board in any subsequent proceeding concerning the facts and circumstances of the particular case if no intervening facts or circumstances arise which would change the opinion of the Board if they had existed at the time the opinion was rendered. However, if any fact determined by the Board to be material was omitted or misstated in the request for an opinion, the Board shall not be bound by the opinion.
- (F) (D) A written advisory opinion issued by the Board shall be admissible in the defense of any criminal prosecution or civil proceeding for violations of this chapter for actions taken in reliance on that opinion.

Section 2. This ordinance shall become effective after passage and publication as required by law.

Council member Dake clarified that there is a difference between an advisory opinion and an ethics complaint. An advisory opinion is occurs when someone requests the opinion of the Ethics Board on the ethics of a proposed act, task or situation, while an ethics complaint alleges that someone has violated the ethics ordinance.

MOTION BY BRADLEY, SECONDED BY BINGHAM TO APPROVE AND ADOPT ORDINANCE 2023-23 AMENDING SECTION 35.59 OF THE VERSAILLES CODE OF ORDINANCES TO REMOVE THE CONFIDENTIALITY PROVISIONS RELATING TO ADVISORY OPINIONS.

At the request of Council member Bradley, City Attorney Moore provided first reading of Ordinance 2023-24 Enacting and Adopting a Supplement to the Code of Ordinances of the City of Versailles, Kentucky.

Council member Miller presented Resolution 2023-18 which would recommend to the Planning Commission to amend the zoning ordinances as they relate to short term rentals inside the city limits. The Council discussed the current zoning ordinances, which do not allow short term rentals in the R-1 zone and only allow them by condition use permit in zones R-2, R-3, and R-4.

Council member Johnson asked how stringent the current conditional use permit process is. Mr. Moore stated that currently a property owner would file an application, notice would be sent to adjoining property owners, and then a public hearing would be held to consider the application.

Council member Dake noted that the vast majority of the short term rentals known to be operating in Woodford County are either in the business district which is zoned commercial or outside the city limits.

Council member Dake mentioned only allowing short term rentals in the commercial zones while Council member Johnson stated that she would prefer to disallow short term rentals in the R-2 zone and continue allowing them via conditional use permit in the R-3 and R-4 zones, which is how the proposed resolution is currently written.

MOTION BY MILLER, SECONDED BY DAKE TO APPROVE AND ADOPT RESOLUTION 2023-18 AMENDING THE ZONING ORDINANCE TEXT FOR INCORPORATED AREA OF VERSAILLES, COMMONWEALTH OF KENTUCKY.
