MINUTES OF REGULAR COUNCIL MEETING
VERSAILLES MUNICIPAL BUILDING/5:30 P.M.**

ROLL CALL: MAYOR BRIAN TRUGOTT PRESIDED OVER THE MEETING. ALSO PRESENT WERE COUNCIL MEMBERS CHANTEL BINGHAM, MARY BRADLEY, LAURA DAKE, LISA JOHNSON, GARY JONES, AND ANN MILLER. CITY ATTORNEY BILL MOORE WAS ALSO PRESENT.

DEPT. HEADS: BART MILLER, T.A. RANKIN, ELIZABETH REYNOLDS AND ROB YOUNG WERE PRESENT REPRESENTING THEIR RESPECTIVE DEPARTMENTS.

PUBLIC COMMENT

Jonathan Woolums addressed the council to complain about Code Enforcement Officer Rock Vance. Mr. Woolums noted that he owns rental property throughout the city and that he strives to keep that property maintained. He stated that Mr. Vance is relentless and has been since a run-in they had in 2020. He complained that Mr. Vance could contact him by email or phone but instead spends taxpayer funds to mail several pages of pictures of violations as well as a citation. He specifically referenced a recent confrontation the two had when Mr. Vance was off the clock. Council member Miller asked questions about a specific violation Mr. Woolums reference involving shopping carts being left on his property and she mentioned that neighbors may have cameras that could show who is leaving the shopping carts in the area. Mr. Woolums encouraged the council to terminate Mr. Vance. He stated that Mr. Vance's actions are harassment.

MOTION BY DAKE, SECONDED BY JOHNSON TO APPROVE AND ADOPT THE MINUTES OF THE DECEMBER 20, 2022 REGULAR MEETING OF THE COUNCIL.

The vote was as follows: Bingham, Bradley, Dake, Johnson, and Jones voting aye. Council member Miller abstained.

MOTION BY MILLER, SECONDED BY BRADLEY TO APPROVE AND ADOPT MUNICIPAL ORDER 2023-1 DESIGNATING COUNCIL MEMBER GARY JONES TO PRESIDE AT CITY COUNCIL MEETINGS IN THE ABSENCE OF THE MAYOR.

Council member Dake stated that in the past we selected the Council member with the most votes and that she would like to continue that. Council member Miller stated that she stands by her motion for Council member Jones to preside. Council member Johnson noted that she assumed she would be filling that role, as she was top vote getter. Council member Jones stated that he was willing to serve but that he would support Ms. Johnson if she wanted to serve.

The vote was as follows: Bradley, Jones, and Miller voting aye. Bingham, Dake, and Johnson voting nay.

The Municipal Order failed to pass due to a tie.

MOTION BY JOHNSON, SECONDED BY DAKE TO APPROVE AND ADOPT MUNICIPAL ORDER 2023-1 DESIGNATING COUNCIL MEMBER LISA JOHNSON TO PRESIDE AT CITY COUNCIL MEETINGS IN THE ABSENCE OF THE MAYOR.

The vote was as follows: Bingham, Dake, Johnson, and Jones voting aye. Bradley and Miller voting nay.

MOTION BY DAKE, SECONDED BY BINGHAM TO APPROVE THE APPOINTMENT OF LONNIE ESTES TO THE PLANNING AND ZONING COMMISSION FOR A TERM BEGINNING JANUARY 3, 2023 THROUGH DECEMBER 31, 2025.

Mayor Miscellaneous

Mayor Traugott praised the Public Works, Fire, Police, and Dispatch for their work during the frigid temperatures and treacherous roads.

Mayor Traugott stated that the regular Council Meeting on January 17th will include an argument-style hearing regarding the zoning map amendment request for Springs of Versailles, LLC.
