ROLL CALL: MAYOR LAURA DAKE PRESIDED OVER THE MEETING. ALSO PRESENT WERE COUNCIL MEMBERS CHANTEL BINGHAM, MARY BRADLEY, LISA JOHNSON, GARY JONES, ANN MILLER, AND FRED SIEGELMAN. CITY ATTORNEY BILL MOORE WAS ALSO PRESENT.

DEPT. HEADS: MAX DAVIS, MITZI DELIUS, BRENT MCGEE, AND ELIZABETH REYNOLDS WERE PRESENT REPRESENTING THEIR RESPECTIVE DEPARTMENTS.

MOTION BY JOHNSON, SECONDED BY JONES TO APPROVE AND ADOPT THE MINUTES OF THE DECEMBER 2, 2025 REGULAR COUNCIL MEETING.

The vote was as follows: Bradley, Johnson, Jones and Miller voting aye. Council members Bingham and Siegelman abstained.

Public Comment

Mick McNulty presented the following statement to the Mayor and Council regarding Formal Objection(s) of Opposition to Proposed Rezoning: R-1C Density within an A-1 Zone:

I respectfully want to formally oppose specific revisions to rezoning the current A-1 to R01C at 1470 Tyrone Pike.

Addressing the A-1 to R-1C Zone Change –

The currently approved projects for Rose Ridge, The Legends, The Anderson Property and Adena Trace will significantly impact traffic and therefore safety in the proposed project area. Approving this project would exacerbate the situation in a significant manner. It is important to wait until there is an actual traffic solution (not just a study) taking all of the currently approved projects into place so that we can see the full impact of that traffic before approving this requested zone change.

Furthermore, based on the significant number of already approved projects not only in this area, but the Versailles Urban Service Boundary in general, I ask the Versailles City Council to consider a “Pause” on all new development proposals inside the urban service boundary. This pause should remain in effect until we can actually see the impact they will have on our community.

The current population of Versailles is approximately 10,000 people. With the already approved building projects currently or soon taking place, this will increase the population by 20+. Over 2200 additional people, along with their vehicles will move into Versailles over the next few years as these projects are completed. This 20+ rise is just in Versailles, not in the broader Woodford County area. I believe that is simply too much growth. Some growth is necessary, but not that much and not in such a concentrated region with no real traffic solution in place.

Therefore, I respectfully urge the City Council to reject the proposed zoning modification and implement the broader pause. I also ask that this document be entered into the meeting minutes record.

CITY OF VERSAILLES
ORDINANCE NO. 2025-20

TITLE: AN ORDINANCE CLOSING THE PUBLIC PASSWAY LOCATED BETWEEN 270 HIGH STREET AND 274 HIGH STREET.

WHEREAS, a public passway sixteen feet in width is presently located between 270 High Street and 274 High Street in the City of Versailles; and

WHEREAS, this public passway has not been utilized by the public for a number of years; and

WHEREAS, KRS 82.405 permits the City to close a public passway if the adjoining property owners agree to the closing; and

WHEREAS, the adjoining property owners of the passway at issue are the City of Versailles and K & J Frye Properties; LLC; and

WHEREAS, the City of Versailles and K & J Frye Properties, LLC have been provided written notice of the proposed closing of the public passway at issue; and

WHEREAS, both the City of Versailles and K & J Frye Properties, LLC have given their written notarized consent to the passway being closing; and

WHEREAS, the City Council has determined that it is appropriate for the City to close such passway.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF VERSAILLES, KENTUCKY as follows:

Section 1. The sixteen foot wide public passway located between 270 High Street and 274 High Street in the City of Versailles is hereby closed for its entire length.

Section 2. The Mayor is authorized to execute and deliver deeds from the City to the adjoining property owners conveying the City's interest in the passway, with each property owner receiving to the midpoint of the passway.

Section 3. This Ordinance shall become effective after the date of its passage and publication as required by law.

Introduced and given first reading at a meeting of the City Council of the City of Versailles, Kentucky, held on the 2nd day of December, 2025, and fully adopted after the second reading at a meeting of said Council held on the 16th day of December, 2025.

Chief Davis noted that the training will be held on the property of the Fire Training Center (Station 3) and they plan to have approximately thirty students. The will fill the spots with Versailles firefighters first and then open it to other members of BERT. He stated that the remaining grant funds will be used to rent equipment needed for the class.

Mayor Miscellaneous
