ROLL CALL:

MAYOR LAURA DAKE PRESIDED OVER THE MEETING. ALSO PRESENT WERE COUNCIL MEMBERS CHANTEL BINGHAM, MARY BRADLEY, LISA JOHNSON, GARY JONES, ANN MILLER, AND FRED SIEGELMAN. CITY ATTORNEY BILL MOORE WAS ALSO PRESENT.

DEPT. HEADS:

BART MILLER, T.A. RANKIN, ELIZABETH REYNOLDS, AND ROB YOUNG WERE PRESENT REPRESENTING THEIR RESPECTIVE

DEPARTMENTS.

MOTION BY SIEGELMAN, SECONDED BY BRADLEY TO APPROVE AND ADOPT THE MINUTES OF THE MAY 27, 2025 SPECIAL WORK SESSION.

The vote was as follows: Bradley, Johnson, Jones, Miller, and Siegelman voting aye. Council member Bingham abstained.

MOTION BY SIEGELMAN, SECONDED BY JOHNSON TO APPROVE AND ADOPT THE MINUTES OF THE JUNE 3, 2025 REGULAR COUNCIL MEETING.

The vote was as follows: Bingham, Bradley, Johnson, Jones, Miller, and Siegelman voting aye.

Public Comment

Dani Bradley, President of The Woodford County Foundation, addressed the council to provide an update of the local non-profit organization and how it has provided assistance to citizens of Woodford County. Ms. Bradley stated that the foundation works with Victim Advocate Ellie Castle, as well as the Family Resource Center for each public school. She noted that some things the foundation was able to provide have included:

- Food, utility payments, and gas for a family traveling back and forth to Cincinnati Children's Hospital for a child battling cancer
- Dental care for a child that school employees had noticed was unable to eat
- Hotel stays during the extreme cold for homeless, prior to the opening of The Warming Station
- Partnered with the Salvation Army during two recent floods
- Transportation to homeless shelters and addiction treatment facilities
- Backpacks for students
- Utility assistance due to job loss, illnesses, etc.
- Work with other non-profits including Bluegrass Community Action, Salvation Army, Versailles Fraternal Order of Firefighters, and the Red Cross

Ms. Bradley stated that the foundation has almost no overhead costs and she expressed their appreciation for the current year funding and asked that the council continue to fund them at \$25,000 per year. She noted that the mission of the foundation is to meet essential needs of Woodford County families. She did note that they currently do not have the funding to provide rental assistance, but they provide assistance with food, gas, utilities, transportation, medical needs, and more. She distributed a letter from Woodford County Public Schools regarding the Fiscal Year 2024-2025 school year which states 20 students were directly impacted, and 80 individuals indirectly impacted, by the assistance provided by The Woodford County Foundation.

Police Chief Rob Young spoke in support of The Woodford County Foundation, stating that they are a valued partner of the police department providing immediate needs in crisis situations.

Deann Watts, Family Resource Coordinator for Huntertown and Southside Elementary Schools, also addressed the council in support of The Woodford County Foundation. Ms. Watts noted that emergencies and unexpected hardships often result in crises for families. She stated that use the foundation as a last resort when other non-profits are unable to provide assistance. Ms. Watts referenced two recent situations where the foundation helped two separate families — one to keep the electric on after a parent was unable to work their outside job because of the weather and one where a medically disabled child living in kinship care needed diapers immediately. She praised the foundation and the work they do to support those needing assistance.

Mayor Dake presented an amendment to the Interlocal Cooperation Agreement Between the City of Versailles and the City of Midway for police services which would reduce the amount paid by the City of Midway for the Fiscal Year 2025-2026 from the original contract amount of 6.5% of the police operating budget to a flat dollar amount of \$401,566.

MOTION BY JOHNSON, SECONDED BY JONES TO APPROVE AND ADOPT THE FIRST AMENDMENT TO THE INTERLOCAL COOPERATION AGREEMENT BETTWEN THE CITY OF VERSAILLES AND THE CITY OF MIDWAY.

Council member Siegelman expressed his opposition to the amendment stating that it is not beneficial to the taxpayers of the City of Versailles.

City Clerk Elizabeth Reynolds clarified that the Interlocal Agreement between the City of Versailles and the Woodford County Fiscal Court states that the Fiscal Court will pay 38% of the police operating budget, after any reimbursement revenues are deducted. She noted that the Agreement does not reference a specific amount for Midway or any other agency that has reimbursed for police services in prior years such as Woodford County Public Schools.

Council member Johnson stated that the cost to the City of approving this amendment is approximately \$32,000 which is .0013% of the City's combined general and enterprise budgets.

Council member Miller noted that while the police operating budget has increased significantly since Fiscal Year 2018, it has been budgeted in good faith.

Mayor Dake noted that, per the Agreement, the City of Midway does not have any negotiation power or "seat at the table" regarding the police department budget. They are simply given a copy of it at the end of the budgeting process and then told what their portion will be. She stated that in conversation with Mayor Vandegrift, they met in the middle at \$401,566 which is approximately 6%.

Mayor Vandegrift addressed the council and stated that no matter what happens tonight, the two cities will continue to be friends and neighbors. He noted that this is not about policing and praised Chief Young and the department. He stated that this is purely about budgeting, noting that they have a total general fund budget of \$2.1 million and that the continuing increases in police costs are taking away from other general fund expenses including sidewalk and road improvements. Mayor Vandegrift stated that he had met with Former Police Chief Murray and Former Mayor Traugott last year and they had assured him that the Fiscal Year 2026 portion would be less than \$404,000. He also noted that in 2019 the City of Midway agreed to pay more than the contract stated at the time because their revenues had increased significantly.

The vote was as follows: Johnson and Jones voting aye. Council members Bingham, Bradley, Miller, and Siegelman voting nay.

Mayor Dake stated listed the employee raises from Fiscal Year 2020 through Fiscal Year 2025 in comparison to the COLA for each year. She noted that budget discussions began in January and February and nobody contacted her regarding the amount of the pay raise for Fiscal Year 2026.

Council member Johnson noted that the City has lost some major employers and she supports keeping the raise at the original budgeted amount of 3%.

Mayor Dake also noted that police and fire employees received significant raises in 2024 in addition to the annual raise.

The vote was as follows (on the Motion to amend Ordinance 2025-8): Siegelman and Bradley voting aye. Council members Bingham, Johnson, Jones, and Miller voting nay.

Council member Miller stated that she appreciates the transparency of the budget but she is uncomfortable with the charitable contributions.

Council member Bingham stated that the amounts budgeted between non-profits is disproportionate and looks discriminatory.

This includes almost immediate support with website changes, payment issues, etc. Mrs. Reynolds stated that Amanda Wainscott, Communications and Events Coordinator, has much more experience with website design and build and that the City is wanting to transition to something more customized, that Ms. Wainscott can design and edit. The plans for the new website include banners, alerts, videos, etc. Mrs. Reynolds stated that the cost for Revize is \$11,250 which includes the first year of maintenance and support which will be \$2,000 annually. She noted that the new website build will take about ten months, so they wanted to get that approved and started. They are still working to determine the best payment platform to use in conjunction with Revize and the current software, Springbrook.

Council Miscellaneous/Committee Reports

Council member Bingham invited everyone to attend the Juneteenth Festival on June 20th 6:00pm – 10:00pm at the Versailles Downtown Market and Entertainment District. She stated that Honeychild will take the stage at 8:00pm.

Mrs. Bingham noted that a Street/Stormwater/Cemetery Committee meeting is scheduled for Monday, July $7^{\rm th}$ at 9:00am.

Council member Siegelman reiterated what Mayor Dake said about Squirrel and expressed his sympathy for his family.

Department Directors

Fire Chief T.A. Rankin provided information on a recent swift water rescue that the Versailles Fire Department provided as part of a mutual aid agreement with Franklin County Fire. He stated that there had been a drowning in the Elkhorn Creek on Saturday and a kayaker and four firefighters became trapped in the creek on Sunday during search operations. Versailles Fire Department was able to safely rescue those who were trapped.

He noted that a lot of the increase has to do with hazardous duty retirement, salaries, and other employee related costs. Chief Young said that the additional pay increase that was given last year was to stay competitive with surrounding departments — he noted that Lexington and UK police departments gave \$20,000 pay raises to all officers and Kentucky State Police gave \$15,000 pay raises to all officers. Chief Young noted that the Versailles Police Department is an accredited department with an SRT team, a trained hostage negotiator, a collision reconstruction team, and they recently created a traffic control team. He also referenced the necessary expense of body cameras and the software that goes with them. Chief Young stated that they are good stewards of taxpayer money and he thanked everyone for their support.

TITLE: AN ORDINANCE AMENDING CHAPTER 31 OF THE VERSAILLES CODE OF ORDINANCES TO REMOVE THE RESPONSIBILITY FOR MANAGING THE WATER AND SEWER DEPARTMENT FROM THE PUBLIC WORKS DIRECTOR AND CREATE THE POSITION OF UTILITIES DIRECTOR TO PERFORM THOSE DUTIES.

Whereas, the City desires to amend Chapter 31 of the City's Code of Ordinances to remove the responsibility for management of the water and sewer department from the duties of the Public Works Director and to create the new position of Utilities Director to assume those responsibilities,

NOW, THEREFORE, BE IT ORDAINED IN THE CITY OF VERSAILLES, KENTUCKY as follows:

Section 1. Section 31.35 of the Versailles Code of Ordinances is hereby amended as follows:

§ 31.35 ESTABLISHMENT.

There is hereby established the position of Public Works Director. The Public Works

Director shall be an employee of the city. The Public Works Director shall direct and

supervise the public works department and the water and sewer department and

perform such other duties as may be assigned by the Mayor.

Section 2. A new section is hereby established in Chapter 31 of the Versailles Code of Ordinances to create the position of Utilities Director as follows:

There is hereby established the position of Utilities Director. The Utilities Director shall be an employee of the city. The Utilities Director shall direct and supervise the water and sewer department, and perform such other duties as may be assigned by the Mayor.

Section 3. This ordinance shall become effective after passage and publication as required by law.

TITLE: AN ORDINANCE AMENDING SECTION 51.32 AND 51.33 OF THE VERSAILLES CODE OF ORDINANCES TO SUBSTITUTE THE NEW POSITION OF UTILITIES DIRECTOR FOR THE PUBLIC WORKS DIRECTOR.

Whereas, the City Council has created the new position of Utilities Director and moved the responsibility of managing the water and sewer department from the Public Works Director to the Utilities Director, and

Whereas, the City Council desires to amend Sections 51.32 and 51.33 of the City's Code of Ordinances to reflect that reassignment of those duties;

NOW, THEREFORE, BE IT ORDAINED IN THE CITY OF VERSAILLES, KENTUCKY as follows:

Section 1. Section 51.32 of the Versailles Code of Ordinances is hereby amended as follows:

§ 51.32 DESIGN AND INSTALLATION.

(A) A separate and independent building sewer shall be provided for every building; except where one building stands at the rear of another on an interior lot and no private sewer is available or can be constructed to the rear building through an adjoining alley, courtyard, or driveway, the sewer from the front building may be extended to the rear building and the whole considered as one building sewer, but the city does not and will

not assume any obligation or responsibility for damage caused by or resulting from any such single connection aforementioned.

- (B) Old building sewers may be used in connection with new buildings only when they are found, on examination and test by the Public Works Director Utilities Director, to meet all requirements of this chapter. Permit and inspection fees for new buildings using existing building sewers shall be the same as for new building sewers. If additional sewer consumers are added to the old building sewers, additional sewer tap fees shall be charged accordingly even though no new sewer tap is actually made into the city system.
- (C) Extension of customer service lines from any point on the customers side of the tap for delivery of waste from any location other than that of the customer in whose name the tap is registered shall not be permitted.
- (D) The size, slope, alignment, materials of construction of a building sewer, and the methods to be used in excavating, placing of the pipe, jointing, testing, and backfilling the trench, shall all conform to the requirements of the local and state building and plumbing codes and other applicable rules and regulations of the city. In the absence of local code provisions or in amplification thereof, the materials and procedures set forth in appropriate specifications of the ASTM and WPCF Manual of Practice No. 9 shall apply.
- (E) All costs and expenses incidental to the installation and connection of the building sewer shall be borne by the owner(s). The owner(s) shall indemnify the city for

any loss or damage that may directly or indirectly be occasioned by the installation of the building sewer. Fees for connection shall be as established by the city.

- (F) The owner shall ensure that all excavations for building installation shall be adequately guarded with barricades and lights so as to protect the public from hazard. Streets, sidewalks, parkways, and other public property disturbed in the course of the work shall be restored in a manner satisfactory to the city.
- (G) In all buildings in which any sanitary facility drain is too low to permit gravity flow to the public sewer, sanitary sewage carried by such drain shall be lifted by an approved means and discharged to the building sewer. Drain pipe and sump for collection of such sanitary drainage shall be above basement floor or in separately watertight or drained sump or channel.
- (H) All building sanitary sewer lines will be installed so as to meet or exceed the most current revision of the State Plumbing Code.
- (I) All persons performing maintenance on city sewers shall use methods and equipment approved by the Public Works Director Utilities Director.
- (J) All necessary cleaning of house connections, including root removal, and the removal of stoppages, from the building to the point of connection to the city's main collector or trunk line shall be the responsibility of the property owner.

Section 2. Section 51.33(A) of the Versailles Code of Ordinances is hereby amended as follows:

§ 51.33 INSPECTION.

(A) All sewer taps shall be inspected after the connection is made to the public sewer and before the connection is covered. The applicant for the building sewer permit shall notify the Public Works Director Utilities Director when the building sewer connection is ready for inspection. The connection and testing shall be made under the supervision of the Public Works Director Utilities Director or his representative. All connections shall be made gastight and watertight and verified by proper testing. Any deviation from the prescribed procedures and materials must be approved in writing by the Public Works Director Utilities Director before installation. The applicant's failure to have the connection inspected pursuant to this section shall authorize the Public Works Director Utilities Director to discontinue water and sewer service to the subject property until an appropriate inspection has been conducted.

Section 3. This ordinance shall become effective after passage and publication as required by law.

Whereas, the City Council has created the new position of Utilities Director and moved the responsibility of managing the water and sewer department from the Public Works Director to the Utilities Director, and

Whereas, the City Council desires to amend Sections 52.02 of the City's Code of Ordinances to reflect that reassignment of those duties;

NOW, THEREFORE, BE IT ORDAINED IN THE CITY OF VERSAILLES, KENTUCKY as follows:

Section 1. Section 52.02 of the Versailles Code of Ordinances is hereby amended as follows:

§ 52.02 DEFINITIONS.

For the purpose of this chapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

"CAPITAL IMPROVEMENTS." Public facilities or assets used for water distribution, transmission, treatment, or any combination.

"CITY." The city of Versailles, Kentucky.

"CITY CLERK." The Clerk of the City of Versailles, Kentucky.

"COUNCIL." The Versailles City Council.

"DEVELOPMENT." All improvements on a site, including buildings, other structures, parking and loading areas, landscaping, paved or graveled areas, and areas devoted to exterior display, storage or activities which have the effect of increasing the demands upon the water utility facilities. "DEVELOPMENT" includes redevelopment of property. "DEVELOPMENT" includes improved open areas such as plaza and walkways, but does not include natural geologic forms or unimproved lands.

"EQUIVALENT RESIDENTIAL UNIT (ERU)." The basis of assigning an impact fee charge. An ERU is the average monthly water demand (usage) by a residential customer. It is calculated, specifically, for Versailles' water utility.

"GROWTH-RELATED EXPANSION." A fee for costs associated with capital improvements to be constructed after the date the fee is adopted pursuant to § 52.04.

"IMPACT FEE." A charge comprised of a systemwide improvements fee (buy-in), a growth-related expansion fee, or a combination thereof, assessed or collected at the time of increased usage of the water utility, at the time of issuance of a development permit or building permit, or at the time of connection to the water system.

- (1) An impact fee charge is not payment or reimbursement for the utility's average cost of inspecting and installing connections with water facilities-that reimbursement is called a "tap fee" and constitutes a separate charge.
- (2) An impact fee charge does not include fees assessed or collected as part of a local improvement district or a charge in lieu of a local improvement district assessment,

or the cost of complying with requirements or conditions imposed by a land use decision.

"LAND AREA." The area of a parcel of land as measured by projection of the parcel boundaries upon a horizontal plane with the exception of a portion of the parcel within a recorded right-of-way or easement subject to a servitude for a public street or for a public scenic or preservation purpose.

"OWNER." The owner or owners of record title or the purchaser or purchasers under a recorded land sales agreement, and other persons having an interest of record in the described real property.

"PARCEL OF LAND." A lot, parcel, block or other tract of land that in accordance with city regulations is occupied or may be occupied by a structure or structures or other use, and that includes the yards and other open spaces required under the zoning, subdivision, or other development ordinances.

"PERMITTEE." The person to whom a building permit, development permit, a permit or plan approval to connect to water system, or right-of-way access permit is issued.

"PROGRAM ADMINISTRATOR." The <u>Public Works Director</u> <u>Utilities Director</u>, or his/her designee, is the impact fee program administrator/coordinator.

"QUALIFIED PUBLIC IMPROVEMENTS." A capital improvement that is:

- (1) Required as a condition of development approval;
- (2) Identified in the plan adopted pursuant to § 52.08 and either:

- (a) Not located on or contiguous to a parcel of land that is the subject of the development approval; or
- (b) Located in whole or in part on or contiguous to a parcel of land that is the subject of the development approval; or
- (c) For purposes of this definition, contiguous means in a public way which abuts the parcel.

"REDEVELOPMENT." Repurposing an existing structure.

"SYSTEMWIDE IMPROVEMENTS FEE (BUY-IN)." A fee for costs associated with capital improvements constructed or under construction on the date the fee is adopted pursuant to § 52.04, and for which the Council determines capacity to exist.

"UTILITY." The water treatment and distribution system of the City of Versailles, Kentucky.

Section 3. This ordinance shall become effective after passage and publication as required by law.

AGREEMENT TO PROVIDE ENGINEERING SERVICES

THIS AGREEMENT TO PROVIDE ENGINEERING SERVICES is entered into on this 1st day of July, 2025, by and between the City of Versailles, Kentucky (hereinafter referred to as "City") and the Versailles-Midway-Woodford County Planning Commission, Kentucky, 103 S Main Street, Versailles, KY, 42383, acting by and through its Director, Steve Hunter (hereinafter referred to as "Planning Commission").

WITNESSETH

WHEREAS, the Planning Commission has a need for construction-related engineering services to assist in the enforcement of the Subdivision Regulations of Woodford County, the Joint City-County Zoning Ordinance and the applicable Kentucky statutes; and,

WHEREAS, the Planning Commission previously employed Mary Beth Robson as its staff engineer from May 23, 2022 to June 30, 2025, and,

WHEREAS, Mary Beth Robson will be employed by the City of Versailles Public Works Department, effective July 1, 2025 and,

WHEREAS, the Planning Commission desires to contract for those same engineering services previously provided by Mary Beth Robson when employed by the Planning Commission, and,

WHEREAS, the Planning Commission and the City have reached agreement pursuant to which the City's Public Works Department will provide construction-related engineering services to the Planning Commission as set out below.

- Attending preconstruction conferences and Planning Commission meetings; and
- Providing any other duties as determined by the City and as requested by the Planning Commission to provide adequate oversight during subdivision plan review, construction and final acceptance and in performing the other obligations set out in this Agreement.

It is understood between the parties that the work required by the City is the first priority of the Public Works' engineer(s) and that the work being performed for the Planning Commission must be performed within the time restraints of the City's engineer(s). It is further understood that the work to be performed pursuant to this Agreement will generally be performed at the offices of the City's Public Works Department during scheduled office hours unless other arrangements are made.

- 2. PAYMENT: The parties agree that the City will be reimbursed at the rate of \$85.07 per hour. Payment by the Planning Commission shall be made on a quarterly basis based on an itemized statement provided by the City indicating the time, date and description of services rendered. This rate is valid for the initial one-year term. This rate will be reviewed annually prior to each agreement term. The rate may be adjusted upon mutual consent of the parties.
- 3. INSURANCE / INDEMNIFICATION: Each party agrees to maintain general liability insurance in amounts satisfactory to the other party. Each Party agrees to indemnify, defend and hold harmless the other party and its officers, directors, elected officials and employees from and against all claims, demands, liabilities, suits, damages, cost and expenses of every kind and description, including penalties and reasonable attorney fees (collectively "damages"), proximately resulting from any act or omission of the indemnifying party or its officers, elected officials, directors or employees.
