ROLL CALL: MAYOR LAURA DAKE PRESIDED OVER THE MEETING. ALSO

PRESENT WERE COUNCIL MEMBERS CHANTEL BINGHAM, MARY BRADLEY, LISA JOHNSON, GARY JONES, ANN MILLER, AND FRED SIEGELMAN. CITY ATTORNEY BILL MOORE WAS ALSO PRESENT.

DEPT. HEADS:

MARLENA JACOBS, BART MILLER, T.A. RANKIN, AND ROB YOUNG WERE PRESENT REPRESENTING THEIR RESPECTIVE DEPARTMENTS.

MOTION BY SIEGELMAN, SECONDED BY BINGHAM TO APPROVE AND ADOPT THE MINUTES OF THE JUNE 17, 2025 REGULAR COUNCIL MEETING.

The vote was as follows: Bingham, Bradley, Johnson, Jones, Miller, and Siegelman voting aye.

Public Comment

Pastor Jo Lauderdale, of Living Grace Church, addressed the council regarding their outreach program, The Station. The Station provides shelter, food, and support during extreme cold or hot temperatures. Ms. Lauderdale stated that this past winter season nine local restaurants contributed food to help serve 248 meals and The Station paid for 25% of those meals out of their budget. She praised the jail for doing the laundry for The Station which has saved them approximately \$3,000. She noted that they started the winter season with ten volunteers and were down to seven by the end of the season. Ms. Lauderdale stated that they served a total of 1,575 hours in service this past season and were fully operational for 55 days. She praised Chief Young for his help and availability. She finished by asking Mayor Dake and the council for financial support for The Station. Mayor Dake responded by asking Ms. Lauderdale to call her.

Fire Chief Rankin provided a presentation regarding the Versailles Fire Department (VFD) Special Operations and Training. He noted their training for structural fires as well as swift water training, structural collapse training, rope rescue, and confined space rescue. He noted their recent receipt of a structural collapse trailer which was funded by a Homeland Security Grant and can also be used for trench rescues. Chief Rankin discussed the training requirements for these additional certifications and stated that the majority of the members of the Versailles Fire Department hold at least three additional discipline certifications beyond the job requirements.

He provided video and photos of a recent swift water rescue that VFD participated in on Elkhorn Creek in Frankfort, Kentucky. Chief Rankin recognized Battalion Chief Max Davis, Lieutenant Bryan Arnett, Captain Josh Slone, Firefighter Joe Bunker, and Firefighter Chris Wood for their work as part of that Elkhorn Creek rescue which saved four firefighters and one civilian.

Chief Rankin shared information about the Bluegrass Emergency Response Team (BERT) which the VFD has been a part of since inception. He noted recent deployments with BERT including a mine collapse in Martin County in 2023, Eastern Kentucky floods in February, 2025 which resulted in the VFD saving the lives of three people, and the Woodford County flood response in April, 2025. He noted the importance of the Special Operations and Training programs to the community as well as to retention of employees and keeping them engaged.

David Duttlinger, Executive Director of Bluegrass Area Development District (BGADD), stated that BGADD supports planning, projects, and programs on the local level. He noted that BGADD provides grant writing assistance to local governments at no cost and they support those staff by getting administrative costs if those grants are awarded. He mentioned the Aging Services and Independent Living Services that they provide known as participant directed services to help people stay in their homes longer. BGADD also runs the Adult Disability and Resource Center to direct people to services they may need. He also mentioned their involvement in local senior citizens centers and meal delivery programs.

Mr. Duttlinger also gave an update on the National Dislocated Worker grant that was recently awarded to the County for displaced workers of Yokohama. He noted that the \$2 million grant provides job search and placement, training and upskills, work-based training, and support services including childcare, transportation, and uniforms/clothing. Mr. Duttlinger stated that the two closest brick and mortar career centers are Lexington and Georgetown, but that he does expect several things to be offered here in Versailles. He also provided information about the Incumbent Worker Training portion of the grant that can reimburse employers for training expenses when hiring displaced workers.

CITY OF VERSAILLES ORDINANCE NO. 2025-12

TITLE: AN ORDINANCE AMENDING CHAPTER 31 OF THE VERSAILLES CODE OF ORDINANCES TO REMOVE THE RESPONSIBILITY FOR MANAGING THE WATER AND SEWER DEPARTMENT FROM THE PUBLIC WORKS DIRECTOR AND CREATE THE POSITION OF UTILITIES DIRECTOR TO PERFORM THOSE DUTIES.

Whereas, the City desires to amend Chapter 31 of the City's Code of Ordinances to remove the responsibility for management of the water and sewer department from the duties of the Public Works Director and to create the new position of Utilities Director to assume those responsibilities,

NOW, THEREFORE, BE IT ORDAINED IN THE CITY OF VERSAILLES, KENTUCKY as follows:

Section 1. Section 31.35 of the Versailles Code of Ordinances is hereby amended as follows:

§ 31.35 ESTABLISHMENT.

There is hereby established the position of Public Works Director. The Public Works Director shall be an employee of the city. The Public Works Director shall direct and supervise the public works department and the water and sewer department and perform such other duties as may be assigned by the Mayor.

Section 2. A new section is hereby established in Chapter 31 of the Versailles Code of Ordinances to create the position of Utilities Director as follows:

There is hereby established the position of Utilities Director. The Utilities Director shall be an employee of the city. The Utilities Director shall direct and supervise the water and sewer department, and perform such other duties as may be assigned by the Mayor.

Section 3. This ordinance shall become effective after passage and publication as required by law.

Introduced and given first reading at a meeting of the City Council of the City of Versailles, Kentucky, held on the $17^{\rm th}$ day of June, 2025, and fully adopted after the second reading at a meeting of said council held on the $1^{\rm st}$ day of July, 2025.

At the request of Council member Miller, City Attorney Moore provided second reading of Ordinance 2025-13 An Ordinance Amending Section 51.32 and 51.33 of the Versailles Code of Ordinances to Substitute the New Position of Utilities Director for the Public Works Director, as follows:

CITY OF VERSAILLES ORDINANCE NO. 2025-13

TITLE: AN ORDINANCE AMENDING SECTION 51.32 AND 51.33 OF THE VERSAILLES CODE OF ORDINANCES TO SUBSTITUTE THE NEW POSITION OF UTILITIES DIRECTOR FOR THE PUBLIC WORKS DIRECTOR.

Whereas, the City Council has created the new position of Utilities Director and moved the responsibility of managing the water and sewer department from the Public Works Director to the Utility Director, and

Whereas, the City Council desires to amend Sections 51.32 and 51.33 of the City's Code of Ordinances to reflect that reassignment of those duties;

NOW, THEREFORE, BE IT ORDAINED IN THE CITY OF VERSAILLES, KENTUCKY as follows:

Section 1. Section 51.32 of the Versailles Code of Ordinances is hereby amended as follows:

§ 51.32 DESIGN AND INSTALLATION.

- (A) A separate and independent building sewer shall be provided for every building; except where one building stands at the rear of another on an interior lot and no private sewer is available or can be constructed to the rear building through an adjoining alley, courtyard, or driveway, the sewer from the front building may be extended to the rear building and the whole considered as one building sewer, but the city does not and will not assume any obligation or responsibility for damage caused by or resulting from any such single connection aforementioned.
- (B) Old building sewers may be used in connection with new buildings only when they are found, on examination and test by the Public Works Director Utilities Director, to meet all requirements of this chapter. Permit and inspection fees for new buildings using existing building sewers shall be the same as for new building sewers. If additional sewer consumers are added to the old building sewers, additional sewer tap fees shall be charged accordingly even though no new sewer tap is actually made into the city system.
- (C) Extension of customer service lines from any point on the customers side of the tap for delivery of waste from any location other than that of the customer in whose name the tap is registered shall not be permitted.
- (D) The size, slope, alignment, materials of construction of a building sewer, and the methods to be used in excavating, placing of the pipe, jointing, testing, and backfilling the trench, shall all conform to the requirements of the local and state building and plumbing codes and other applicable rules and regulations of the city. In the absence of local code provisions or in amplification thereof, the materials and procedures set forth in appropriate specifications of the ASTM and WPCF Manual of Practice No. 9 shall apply.
- (E) All costs and expenses incidental to the installation and connection of the building sewer shall be borne by the owner(s). The owner(s) shall indemnify the city for any loss or damage that may directly or indirectly be occasioned by the installation of the building sewer. Fees for connection shall be as established by the city.
- (F) The owner shall ensure that all excavations for building installation shall be adequately guarded with barricades and lights so as to protect the public from hazard. Streets, sidewalks, parkways, and other public property disturbed in the course of the work shall be restored in a manner satisfactory to the city.
- (G) In all buildings in which any sanitary facility drain is too low to permit gravity flow to the public sewer, sanitary sewage carried by such drain shall be lifted by an approved means and discharged to the building sewer. Drain pipe and sump for collection of such sanitary drainage shall be above basement floor or in separately watertight or drained sump or channel.
- (H) All building sanitary sewer lines will be installed so as to meet or exceed the most current revision of the State Plumbing Code.
- (I) All persons performing maintenance on city sewers shall use methods and equipment approved by the Public Works Director Utilities Director.

(J) All necessary cleaning of house connections, including root removal, and the removal of stoppages, from the building to the point of connection to the city's main collector or trunk line shall be the responsibility of the property owner.

Section 2. Section 51.33(A) of the Versailles Code of Ordinances is hereby amended as follows:

§ 51.33 INSPECTION.

(A) All sewer taps shall be inspected after the connection is made to the public sewer and before the connection is covered. The applicant for the building sewer permit shall notify the Public Works Director Utilities Director when the building sewer connection is ready for inspection. The connection and testing shall be made under the supervision of the Public Works Director Utilities Director or his representative. All connections shall be made gastight and watertight and verified by proper testing. Any deviation from the prescribed procedures and materials must be approved in writing by the Public Works Director Utilities Director before installation. The applicant's failure to have the connection inspected pursuant to this section shall authorize the Public Works Director Utilities Director to discontinue water and sewer service to the subject property until an appropriate inspection has been conducted.

Section 3. This ordinance shall become effective after passage and publication as required by law.

Section 1. Section 52.02 of the Versailles Code of Ordinances is hereby amended as follows:

§ 52.02 DEFINITIONS.

For the purpose of this chapter, the following definitions shall apply unless the context clearly indicates or requires a different meaning.

"CAPITAL IMPROVEMENTS." Public facilities or assets used for water distribution, transmission, treatment, or any combination.

"CITY." The city of Versailles, Kentucky.

"CITY CLERK." The Clerk of the City of Versailles, Kentucky.

"COUNCIL." The Versailles City Council.

"DEVELOPMENT." All improvements on a site, including buildings, other structures, parking and loading areas, landscaping, paved or graveled areas, and areas devoted to exterior display, storage or activities which have the effect of increasing the demands upon the water utility facilities.

"DEVELOPMENT" includes redevelopment of property. "DEVELOPMENT" includes improved open areas such as plaza and walkways, but does not include natural geologic forms or unimproved lands.

"EQUIVALENT RESIDENTIAL UNIT (ERU)." The basis of assigning an impact fee charge. An ERU is the average monthly water demand (usage) by a residential customer. It is calculated, specifically, for Versailles' water utility.

"GROWTH-RELATED EXPANSION." A fee for costs associated with capital improvements to be constructed after the date the fee is adopted pursuant to § 52.04.

"IMPACT FEE." A charge comprised of a systemwide improvements fee (buy-in), a growth-related expansion fee, or a combination thereof, assessed or collected at the time of increased usage of the water utility, at the time of issuance of a development permit or building permit, or at the time of connection to the water system.

- (1) An impact fee charge is not payment or reimbursement for the utility's average cost of inspecting and installing connections with water facilities-that reimbursement is called a "tap fee" and constitutes a separate charge.
- (2) An impact fee charge does not include fees assessed or collected as part of a local improvement district or a charge in lieu of a local improvement district assessment, or the cost of complying with requirements or conditions imposed by a land use decision.

"LAND AREA." The area of a parcel of land as measured by projection of the parcel boundaries upon a horizontal plane with the exception of a portion of the parcel within a recorded right-of-way or easement subject to a servitude for a public street or for a public scenic or preservation purpose.

"OWNER." The owner or owners of record title or the purchaser or purchasers under a recorded land sales agreement, and other persons having an interest of record in the described real property.

"PARCEL OF LAND." A lot, parcel, block or other tract of land that in accordance with city regulations is occupied or may be occupied by a structure or structures or other use, and that includes the yards and other open spaces required under the zoning, subdivision, or other development ordinances.

"PERMITTEE." The person to whom a building permit, development permit, a permit or plan approval to connect to water system, or right-of-way access permit is issued.

"PROGRAM ADMINISTRATOR." The Public Works Director Utilities Director, or his/her designee, is the impact fee program administrator/coordinator.

"QUALIFIED PUBLIC IMPROVEMENTS." A capital improvement that is:

- (1) Required as a condition of development approval;
- (2) Identified in the plan adopted pursuant to § 52.08 and either:
- (a) Not located on or contiguous to a parcel of land that is the subject of the development approval; or
- (b) Located in whole or in part on or contiguous to a parcel of land that is the subject of the development approval; or
 - (c) For purposes of this definition, contiguous means in a public way which abuts the parcel. "REDEVELOPMENT." Repurposing an existing structure.

"SYSTEMWIDE IMPROVEMENTS FEE (BUY-IN)." A fee for costs associated with capital improvements constructed or under construction on the date the fee is adopted pursuant to \S 52.04, and for which the Council determines capacity to exist.

"UTILITY." The water treatment and distribution system of the City of Versailles, Kentucky.

Section 3. This ordinance shall become effective after passage and publication as required by law.

Mayor Miscellaneous

Mayor Dake announced the 4th of July Parade will be held downtown on Friday from 12:00pm – 2:00pm and then the festivities will begin at 6:00pm at the Woodford County Football Stadium with games, activities for kids, inflatables, music, and food vendors with fireworks beginning at dark.

She noted that everyone is invited to the Woodford County Fair Horse Races which will be held July 5^{th} 12:00pm -5:00pm at Highbramble Park. She noted that it is a family event with food and drinks available for sale as well as activities for children.

She announced the hiring of Marybeth Robson as City Engineer and the recent promotion of Mitzi Delius to Utilities Director.

Mayor Dake noted that the July-August edition of the City Newsletter will go out tomorrow.

Council member Miller stated that the Manufactured Home Ribbon Cutting was held yesterday, June 30th, at the pilot project on High Street. She stated that the Housing Task Force is continuing to move forward and looks forward to meeting again in August.

Mayor Dake stated that there were three prequalified candidates who entered into the random drawing to purchase the house. She noted that Logan Hanes with the Kentucky Manufactured Housing Institute is facilitating the sale of the house and they have not drawn a name yet.

She also stated that House Bill 160 was signed into law in April which allows manufactured housing to be placed in any residential zone throughout the state of Kentucky. She stated that individual cities can create criteria for those manufactured homes, but they cannot be any stricter than requirements placed on site built homes.

Council Miscellaneous/Committee Reports

Council member Jones stated that the Water and sewer Committee met this afternoon regarding a adjustment request for 181 Gleneagles Way. He stated that they had a leak on the City side of the meter beginning in December. They have already received an adjustment for April and May, but the committee is asking the council to approve an adjustment for the June bill in the amount of \$215.67. 



CITY OF VERSAILLES, KENTUCKY CEMETERIES RULES AND REGULATIONS

Thank you for entrusting the care of your deceased loved one's resting place to the City of Versailles, Kentucky (hereafter "the City") and its cemetery employees. These Rules and Regulations allow the City to maintain its cemeteries in the best way conceivable as a place of solace and comfort. As much as possible, we wish to accommodate the memorial intent of those who care for the graves of loved ones buried in our cemeteries without disturbing or distracting from the peaceful and reverent intent of the cemeteries themselves.

The City of Versailles owns three cemeteries: Versailles Cemetery, Rose Crest Cemetery, and Simmons Cemetery. These Rules and Regulations apply to all three and have been reviewed and approved by Versailles City Council to govern the operations and maintenance functions of city-owned cemeteries. The Rules and Regulations are administered daily by the City's Cemetery Superintendent.

If you have questions or concerns regarding these Rules and Regulations, you may contact the City's Cemetery Superintendent at (859) 873-4241.

GENERAL RULES OF CONDUCT

Cemeteries are considered sacred ground and places of reverence. We request that:

- Vehicles are driven at no more than 10 miles per hour within the grounds to limit traffic noise as much as possible and to ensure the safety of visitors and cemetery employees;
- Visitors are fully clothed, including shoes and shirts;
- Visitors refrain from holding parties, picnics or sports activities of any kind on the grounds;
- No dogs are brought within the boundaries of the city's cemeteries with the exception of service dogs¹.

The City reserves the right to prohibit public entry to city cemeteries when the safety of visitors and preservation of the cemetery is threatened by bad weather or similar factors.

INTERMENTS, OR BURIALS

- Interments, which include both entombments (burying a body in a grave) and inurnments (burying of ashes in an urn following cremation) will be made by the City's Cemetery employees or their designees only.
- Interments will be made only after obtaining:
 - a. authorization of the owner of the cemetery lot;

- b. authorization of the nearest relative of the deceased; and
- Location is to be determined and approved by val of the Cemetery Superintendent based on planned design and availability.
- 3. The City will not be held responsible for any order authorizing an interment that is given by telephone or for any mistake occurring because of inaccurate instructions.
- 4. All funerals within the cemetery are subject to a 2-hour time limit.

For entombments:

- Body must be placed in a rigid container (casket/coffin) with handles for carrying. Containers must be approved by the City's Cemetery Superintendent.
- All caskets/coffins must be placed in an approved vault.
- Mausoleums and columbariums are permitted prohibited in cemeteries based on planned design and availability.

Mausoleum Specifications:

- a. A warranty for the life of the materials used and the workmanship required by the manufacturer.
- b. Outside walls must meet the specifications necessary for the size of the structure to properly support all parts of the building. Wall thickness may vary from 4 inches for garden crypt-typer buildings to 8-inch thickness for larger buildings.
 - 1. The building must be constructed using natural stone product, preferably domestic granite.
 - 2. Materials to meet NBGQA (National Building Granite Quarries Association) specifications.
- C clamps and appropriate epoxy must be used on all wall joints.
- d. Gabled roofs must be mortise and tenon.
- e. All joints must be sealed with GE Silicone NB and appropriate sized backer rod.
 - In lieu of solid granite flooring, concrete floors may be used. Pre-cast concrete shall be a minimum of 4000 PSI and of a certified engineered design. Cast in place large mausoleums shall be engineered and concrete shall meet ASTM (American Society for Testing and Materials) standard 94C and shall be 4000 PSI.
- g. Crypts cannot be an integral structural component of the mausoleum. Certifiedengineered pre-cast concrete crypts and shelves may be used.
- h. Interior crypt shelves must be four inches thick.
- i. The back wall must be one solid piece with any window structure cut from that solid piece, unless the wall is locked into position from the floor below the wall and the rod above the wall.
- j. A detailed blueprint of the building and foundation is required prior to construction.

- k. It is highly recommended, but not required, that the building have separate interior wall made of either granite or marble to prevent interior wall moisture.
- <u>Maintenance and upkeep of the mausoleums and columbariums are the sole responsibility of the family, not the Cemetery Superintendent.</u>

For inurnments:

- There is a limit of three (3) cremains that can be placed in a regular, full-size grave. One (1) cremains and one (1) vault may be placed in a grave.
- Scattering of cremains in the cemeteries is prohibited.
- <u>Section D</u> at Rose Crest Cemetery has an area designated solely for cremains burials. The following information applies to this area only:
 - a. Cremains lot sizes are 40" x 48".
 - b. Up to two urns may be buried in each cremains lot.
 - c. Only flat, ground-level markers, no larger than three (3) feet long and one (1) foot wide, are permitted in this area. One marker is permitted per buried urn.
 - d. The ONLY decorations allowed in Section D are flowers placed directly on markers, and no more than 21 days before Christmas and 21 days after Christmas, and no more than 21 days before Memorial Day and 21 days after Memorial Day, at which time they may be removed by cemetery employees.

CEMETERY LOTS

Ownership:

1. The Cemetery will not recognize transfers of ownership by will unless notified at the time the will is written.²

- a. All cemetery lots sold after March 7, 1972, are restricted from being resold to anyone other than the City, excluding only immediate members of the owner's family.
- b. In the event any lot is repurchased by the City, the lot will be repurchased at the price paid for at original purchase of cemetery lot.³
- c. This information will be included in all sales agreements of lots sold and will be contained in any deed conveying the lot.

Plantings/Flowers:

For purposes of the rules below regarding plantings and flowers and other decorative items, a "bordered area" is defined as an area that extends no more than eighteen inches (18") from the front of the headstone or marker and does not exceed the width of the headstone or marker. The border must consist of a stone or concrete material that is no higher than four inches (4") off the ground.

- With the advance approval of the Cemetery Superintendent, lot owners may plant trees and shrubs directly behind their headstones or markers if their lots adjoin a planting row. To achieve symmetry and best general result, all planting and pruning must be approved by the Cemetery Superintendent. No tree or shrub within any lot may be cut down or destroyed without the consent of the Cemetery Superintendent. If any tree or shrub becomes detrimental to any adjacent lot, walking path, or grounds maintenance, cemetery employees may remove the tree or shrub at the expense of the lot owner on which it stands.⁴
- Natural flowers and plants are permitted at any time and are removed when wilted. The pots or baskets containing such plants must be secured on headstones or placed in the bordered areas.
- 3. Flower beds of spring bulbs or summer annuals may be planted but only in the bordered areas. Cemetery employees may remove a flower bed if it becomes unkept.
- Artificial flowers are permitted on headstones or in bordered areas year-round but may be removed by cemetery employees if they become faded or deteriorated.

Other Decorative Items:

- 5. Toys, shells, decorative stones, and similar articles are permitted only on a headstone or when placed in a bordered area.
- 6. Two shepherd hooks are permitted per cemetery lot and must be placed in the bordered area only (or, if there is not a bordered area, against the headstone). The hooks and the decorations on the hooks must not hang over the area outside the bordered area or headstone.

REVISED JULY 7, 2025

- Any decorations placed on a lot which do not conform to the cemetery's policies will be removed by cemetery employees. Prohibited items include items with advertising (e.g., food and beverage containers), items that may be deemed offensive, and clothing items.
- 8. Items of a nature unique to a holiday are allowed in permitted areas no more than 21 days before the holiday and may remain for no more than 21 days following the holiday, at which time they may be removed by cemetery personnel.
- Articles made of concrete (e.g., urns and boxes) are permitted only in bordered areas because such articles add greatly to the cost of maintenance. No fencing or trellises of any type is allowed.

The City bears no responsibility for loss or damage from causes beyond its reasonable control, including, but not limited to, regular maintenance, thieves, vandals, explosions, unavoidable accidents or acts of God.

MEMORIALS (OR HEADSTONES)

- Granite, marble or bronze are recommended as the most durable materials for headstones.
 Temporary or permanent headstones made of wood, concrete, artificial stone, composite, tin, or iron are not permitted.
- 2. Only one central or family memorial may be placed on any family lot. The location of all headstones is determined by the Cemetery Superintendent.
- 3. Only one marker is permitted per grave space. (Exception is made in the case of a U.S. government-issued flat, ground-level marker which shows the deceased's military service.)
- 4. No headstone may be placed on any lot where there are unpaid fees.
- No headstone may be erected or placed on any lot in the cemetery without the Cemetery Superintendent's approval.
- 6. All foundations for memorials must be installed by cemetery employees. The City will assume responsibility for the proper construction of such foundations.
- 7. The City reserves the right to exclude or remove from any lot, a headstone or other structure which is determined by the City to be offensive, improper or injurious to the surrounding lots or grounds, or which has become dilapidated or unsightly.⁵

USE OF THE ROSE CREST CEMETERY PAVILION

All funeral homes must abide by the guidelines below.

- 1. Funeral homes will transport remains to the Rose Crest Cemetery Pavilion.
- Designated pallbearers will remove remains from hearse/carriage to the pavilion at the discretion of the funeral director and place remains on a bier (a frame or stand on which a casket or coffin is laid) at the Pavilion.
- 3. At the end of the service, the pallbearers will place the remains back into the hearse/carriage.
- 4. The hearse/carriage will transport the remains to the gravesite.
- 5. Cemetery employees will remove the remains from the hearse/carriage and place on funeral cart for immediate burial.
- For safety reasons, the City requests that no mourners (persons attending the burial service as relatives/friends of the deceased) be allowed to go to the gravesite until the remains are in place to be professionally buried.
- 7. All funerals are subject to a 2-hour time limit from bier to interment.
- 8. If a family or funeral home requests a tent or other graveside accessories at the actual burial site, there will be an additional charge. (See list of fees.)
- The Rose Crest Cemetery Pavilion is also available for services if the burial lot is at Versailles Cemetery.
- 10. All funeral homes are required to provide their own lowering devices to lower remains into the vault.

The City may, from time to time, amend these Rules and Regulations as necessary for the care of the cemeteries and protection of lot owners. The above Rules and Regulations do not constitute all the rules and regulations of the cemeteries, but only those most pertinent to owners and visitors.
