ROLL CALL: MAYOR LAURA DAKE PRESIDED OVER THE MEETING. ALSO

PRESENT WERE COUNCIL MEMBERS CHANTEL BINGHAM, MARY BRADLEY, LISA JOHNSON, GARY JONES AND FRED SIEGELMAN. CITY ATTORNEY BILL MOORE WAS ALSO PRESENT. COUNCIL MEMBER

ANN MILLER WAS ABSENT.

AND ROB YOUNG WERE PRESENT REPRESENTING THEIR

MOTION BY BRADLEY, SECONDED BY SIEGELMAN TO APPROVE AND ADOPT THE MINUTES OF THE NOVEMBER 4, 2025 REGULAR COUNCIL MEETING.

The vote was as follows: Bingham, Bradley, Johnson, and Siegelman voting aye. Council member Jones abstained.

Public Comment

No public comment was received.

Mayor Dake presented Municipal Order 2025-16 which renames the portion of the street from U.S. Highway 60 through the roundabout and continuing straight back to the end of the new street. The Order states that the portion of the street exiting the roundabout to the west, through the Versailles Center, will retain the name of Kroger Way. Mayor Dake stated that the new name would be Governors Lane, in honor of several Kentucky Governors that have a connection to Woodford County. She also noted that they chose Lane as a nod to Former Governor Martha Layne Collins, who recently passed away.

Public Works Director Bart Miller noted that the "park" beside City Hall was named Governors Park in 1995 and there is a plaque recognizing six Kentucky Governors who resided in Woodford County at one time. Mayor Dake stated that this is actually the subject of this week's "Two Minutes with the Mayor".

MOTION BY SIEGELMAN, SECONDED BY JOHNSON TO APPROVE AND ADOPT MUNICIPAL ORDER 2025-16 A MUNICIPAL ORDER RENAMING A PORTION OF THE CITY STREET FORMERLY KNOWN AS KROGER WAY FROM U.S. HIGHWAY 60 THROUGH THE ROUNDABOUT AND CONTINUING TO THE END OF THE NEW CITY STREET.

Department Directors

Public Works Director Miller stated that the City pays Kentucky Utilities a set cost per month for each streetlight, whether they are working or not. He encouraged residents to contact KU or City Hall if they see a light out.

Fire Chief T.A. Rankin presented the following quotes for excavation work for a new training facility on the Versailles Fire Training Center property on Huntertown Road:

Grubbs Excavating	\$28,500
Clay's Ground Services	\$32,500
PST Septic & Excavation	\$38,650

Chief Rankin stated that each quote includes preparing the site, extending the parking lot, and gravel. He noted that the current budget includes \$100,000 for this project and they had also been awarded a grant for \$25,000. They had asked for \$75,000 when they applied for the grant, and plan to apply for additional grant funds when it opens up again. He said the project could be a two-three year project depending on whether they receive additional grant funds.

MOTION BY SIEGELMAN, SECONDED BY BINGHAM TO APPROVE AND ACCEPT THE QUOTE AS PROVIDED BY GRUBBS EXCAVATING FOR THE EXCAVATION WORK FOR A NEW VERSAILLES FIRE DEPARTMENT TRAINING FACILITY ON THE HUNTERTOWN ROAD PROPERTY IN THE TOTAL AMOUNT OF \$28,500.00.

CITY OF VERSAILLES ORDINANCE NO. 2025-20

TITLE: AN ORDINANCE CLOSING THE PUBLIC PASSWAY LOCATED BETWEEN 270 HIGH STREET AND 274 HIGH STREET.

WHEREAS, a public passway sixteen feet in width is presently located between 270 High Street and 274 High Street in the City of Versailles; and

WHEREAS, this public passway has not been utilized by the public for a number of years; and

WHEREAS, KRS 82.405 permits the City to close a public passway if the adjoining property owners agree to the closing; and

WHEREAS, the adjoining property owners of the passway at issue are the City of Versailles and K & J Frye Properties; LLC; and

WHEREAS, the City of Versailles and K & J Frye Properties, LLC have been provided written notice of the proposed closing of the public passway at issue; and

WHEREAS, both the City of Versailles and K & J Frye Properties, LLC have given their written notarized consent to the passway being closing; and

WHEREAS, the City Council has determined that it is appropriate for the City to close such passway.

NOW THEREFORE, BE IT ORDAINED BY THE CITY OF VERSAILLES, KENTUCKY as follows:

Section 1. The sixteen foot wide public passway located between 270 High Street and 274 High Street in the City of Versailles is hereby closed for its entire length.

Section 2. The Mayor is authorized to execute and deliver deeds from the City to the adjoining property owners conveying the City's interest in the passway, with each property owner receiving to the midpoint of the passway.

Section 3. This Ordinance shall become effective after the date of its passage and publication as required by law.
