Prior to the start of the meeting, Mayor Traugott announced that at a recent auction supporting Kings Way Cooperative School he had donated a "Mayor for the Day" package. He stated that Riley Baker was the highest bidder and he is spending today, his eighth birthday, as Mayor. "Mayor" Baker spent the day writing a proclamation, participating in an interview with the press, and visiting the Police and Fire Departments as well as the Waste Water Treatment Plant. Mayor Traugott noted that "Mayor Baker" would be opening the Council meeting.

"Mayor" Riley Baker presented a Proclamation to the Council declaring today, June 7, 2022, as Pajama Candy Day which would allow everyone to wear pajamas all day and eat candy.

MOTION BY SIEGELMAN, SECONDED BY DAKE TO APPROVE THE PROCLAMATION AS PRESENTED DECLARING JUNE 7, 2022 AS PAJAMA CANDY DAY.

The vote was as follows: Bradley, Dake, Johnson, Kerkhoff and Siegelman voting aye.

"Mayor" Baker then signed the Proclamation into legislation.

Council member Siegelman led the Council in singing Happy Birthday to "Mayor" Baker. Mr. Baker then turned the meeting over to Mayor Traugott.

### **PUBLIC COMMENT**

Toni Curtis, a resident of Montgomery Avenue, addressed the Mayor and Council regarding the traffic on Montgomery Avenue. Ms. Curtis had previously discussed the issues at the January 18, 2022, council meeting and she requested an update on connectivity, particularly with the new Legends development. She noted that she had reviewed the minutes of the City Council and the council approved the closing of Meadow Lane in 2006. Mayor Traugott stated that Legends will connect, currently on schedule for Fall, 2023. Mayor Traugott noted that he doesn't anticipate any changes on Meadow Lane. Ms. Curtis expressed her concern that the connectivity for Meadow Lane was proposed, planned, and promised but then didn't happen because those constituents were vocally against it. Police Chief Murray stated that the addition of speed radars on Montgomery Avenue has slowed drivers down, with the average speed being just a couple over the speed limit of 25 MPH.

J.D. Chaney, Executive Director of Kentucky League of Cities, stated that as KLC President, Mayor Traugott has traveled with him and Doug Goforth, Deputy Executive Director of KLC, across Kentucky to participate in "Presidential Listening Sessions" with different cities across the Commonwealth. Mr. Chaney stated that this past session has been the most successful legislative agenda in history for Kentucky cities with 26 of 31 items passing. He provided an update on the items that passed and not that the issues on the horizon include wage inflation and employee retention.

# CITY OF VERSAILLES ORDINANCE NO. 2022-10

TITLE: AN ORDINANCE REQUIRING JOINTLY CREATED AGENCIES TO ADOPT POLICIES CONCERNING COMPLAINTS OF HARASSMENT AND APPEALS FROM AGENCY DECISIONS.

Whereas, the City has joined with City of Midway and/or the Woodford Fiscal Court to create by interlocal agreement various governmental agencies that provide and perform necessary governmental services for the citizens of the Cities and Woodford County; and

Whereas, these agencies have governing boards, employees and other staff who are not under the direct control of the City or any other creating government; and

Whereas, employees and staff of these agencies may have legitimate cause to complain about their work environment or other circumstances related to their employment; and

Whereas, the City has determined that these agencies would benefit from the adoption of policies and procedures for these complaints to be addressed before the need arises to apply those policies and procedures,

NOW, THEREFORE, BE IT ORDAINED IN THE CITY OF VERSAILLES, KENTUCKY as follows:

Section 1. Any entity that is created in whole or in part by action of the City of Versailles and any entity that receives more than forty percent (40%) of its total funding from appropriations by the City shall adopt policies and procedures within ninety (90) days of the effective date of this ordinance that addresses the following issues:

- A. A policy concerning harassment, both sexual and nonsexual, that includes:
- i. Specific protections from retaliation against employees or others who file a sexual or nonsexual harassment complaint;
- ii. A procedure for an employee or other person to file a complaint against the head of the agency; and
- iii. A written procedure to inform employees of the agency's policies with regard to sexual and nonsexual harassment that includes, at a minimum, making a complaint form readily available.
- B. A procedure for customers or clients receiving services by the agency to appeal decisions made by the head of the agency;

Section 2. This ordinance shall become effective after passage and publication as required by law.

Introduced and given first reading at a meeting of the City Council of the City of Versailles, Kentucky, held on the  $17^{th}$  day of May , 2022, and fully adopted after the second reading at a meeting of said council held on the  $7^{th}$  day of June, 2022.

#### **Council Miscellaneous/ Committee Reports**

Council member Siegelman reminded everyone to go out and enjoy the Woodford County Fair this week. He also expressed his condolences in the recent passing of Ms. Parrott and Ms. Turner.

Council member Dake stated that a Water and Sewer Committee meeting was held prior to tonight's council meeting. On behalf of the committee, she recommended a sewer adjustment for 190 Kilmer in the amount of \$326.31.

MOTION BY DAKE, SECONDED BY BRADLEY TO APPROVE A SEWER ADJUSTMENT FOR 190 KILMER IN THE AMOUNT OF \$326.31.

The vote was as follows: Bradley, Dake, Johnson, Kerkhoff and Siegelman voting aye.

Ms. Dake said that the committee also discussed a leak adjustment request for 2875 Tyrone Pike. She stated that in four months the billed amount totaled over \$1,841.00 and the customer paid \$740.00 to repair the leak. She stated that the customer had their bill auto-deducted from their bank account and didn't realize the bill was drastically higher than normal, until the third month. She noted that the committee hasn't made a recommendation and would like to discuss it further with the full council. Mayor Traugott reminded the council that there are fixed and variable costs associated with all water used. The council decided to discuss this incident, as well as the policy overall, at next week's work session.

Ms. Dake noted that she had sent a survey via email for Livable Woodford. She encouraged everyone to participate by completing the survey.

Ms. Dake stressed her desire to make Versailles livable. She described a personal incident she encountered as a pedestrian in a crosswalk. She stated that she would like to see downtown made safer for pedestrians and suggested possibilities including a left turn signal at the traffic light in front of the Courthouse, highly reflective lines, and signs stating that vehicles must yield to pedestrians. Mayor Traugott commented that both times he has asked the state for a left turn signal, they respond that it will stack and impair another intersection.

Council member Johnson stated that the Building Standards and Downtown Development Committee met in May and June and that the RFQ relating to the traffic study is due June 15<sup>th</sup> at 3:00pm.

Ms. Johnson thanked those involved for a meaningful Memorial Day service and she noted that it was especially touching for her as her daughter just left for a six month deployment.

## **Department Directors**

Public Works Director Miller stated that based on recent project meetings, he is optimistic that the Smart Meter Project will begin this year.

Mr. Miller reminded everyone that City Hall will be closed June 20th in observance of Juneteenth.

He also stated that the City Hall windows will be cleaned next week and then shades installed and that will complete the project.

Mr. Miller congratulated Mayor Traugott on being unopposed in the upcoming Mayor's race.

Chief Rankin thanked everyone who donated in the recent Crusade for Children collections. He stated that a total of \$20,000 was raised in Woodford County.

Chief Rankin stated that they are going to look at the new firetruck they ordered in the next couple of weeks. He also congratulated Magistrate Mary Ann Gill on her recent retirement from St. Joseph East after over 40 years.

Mayor Traugott commended the Versailles Fire Department on their recent response on Memorial Day to a structure fire. He noted that the fire was extinguished efficiently and there were no injuries.
