#### Did You Know?

## That the City writes grant proposals for funding?

Most people know that nonprofits write grants to fund their operations and special programs.

#### Did you know that cities do the same?

Many municipal projects are paid for with state or federal monies, especially ones that aren't feasible with local tax dollars alone or ones that aim to encourage cities to try something new and different.

Some recent examples include:

\$500,000 = New sidewalk, etc. on Wilson Avenue

**\$108,400** = Safe Streets & Roads for All grant for "quick build" demonstration projects to improve traffic safety on Lexington and Midway Roads

**\$286,000** = Paratech Structural Collapse Trailer (Versailles Fire Department)

In future newsletters, we'll tell you more about these grants (and others) that the city is trying for or has received.

The money from these grants is critical to improving public safety, building resilient infrastructure, and strengthening equity for all residents.



## Nonprofit Spotlight: CASA of Lexington!



Woodford County's CASA (Court Appointed Special Advocates) program is a nonprofit that matches abused and neglected children with trained and supported community volunteers,

who visit the children regularly and advocate for any needs they might have. Children in the family court system who receive a CASA volunteer are more likely to do well in school, receive the services they need to thrive, and return to safe, permanent homes that never disrupt again.

It takes 5-10 hours a month to serve as a CASA volunteer, and no special education or background is required. CASA volunteers provide regular, commonsense perspectives on children's needs, helping to keep everyone on the case focused on what matters most. They also develop relationships with the children they serve, giving them hope for the future and showing them that someone cares about what happens to them.

In Woodford County, there are about 90 abused or neglected children with open family court cases. In 2023, eighteen (18) Woodford CASA volunteers served 26 of these children. The next in-person training class for new CASA volunteers begins on January 9, 2025, in Lexington, with classes on evenings and weekends. Online training classes are also regularly available.

Woodford County numbers from CASA of Lexington: In 2023, there were 44 new cases of children being abused or neglected in Woodford County. Through the <u>first nine months of 2024</u>, there were another 41 new cases of child abuse or neglect, which means Woodford is on-track to see an increase in total cases compared to 2023.

#### What is the Process for Choosing a New Mayor?

Former Versailles mayor Brian Traugott resigned effective October 1<sup>st</sup> to take a job at the Kentucky League of Cities. Because he wasn't up for reelection until 2026, his resignation means that there are still more than two years in his term to fill. This Q&A below explains what happened in October and why the appointment of a new mayor now resides with Governor Andy Beshear.

What happens when a mayor announces a resignation before the end of his/her term? In Kentucky, the City Council has 30 days to appoint a new mayor. In this case, the Council had from October 1-30. The Council could have made its decision at a regularly scheduled meeting or called a special meeting. A special meeting requires at least four of the six council members vote to schedule one.

What happened in October then? No consensus was reached on a new mayor. Names of interested city council members were put forward, but no one got the number of votes required to be appointed. Therefore, as of October 31st, the decision went to the governor.

How many votes would have been required to appoint someone? A simple majority would have been required. The persons interested in the position cannot vote for themselves, although they can nominate themselves. So, if a council member is nominated, that leaves five people available to vote. The interested person must then receive at least three "yes" votes (or two "yes" votes and two abstentions) to be appointed.

Now that the decision has gone to the Governor, does this mean he has to choose someone on city council? No, he does not. The only requirements are that the person be at least 21 years old and live in the city limits of Versailles. Presumably, the person would have to want to be mayor, too!

Because the city council couldn't come to a consensus, does this mean that the members don't work well together? Not at all. It just means that more than one person is interested in the position. This Council has worked very well together for the past two years, and we anticipate more of the same once a new mayor is appointed. Smooth functioning of the city is very important to us.

How long does the Governor have to decide on a replacement for former Mayor Traugott? That's a good question! We don't know – this apparently doesn't happen very often – but we assume it'll be within the month.

Will the person appointed have to run in 2026 if he/she wants to continue to serve as mayor? That's an easy one – yes!
